## **IMPORTANT INFORMATION:**

- 1. This show is limited to 120 cats.
- 2. Closing Date: 21 February 2025 @ 24h00 or when 120 limit is reached.
- 3. RCC moved to a new bank account. RCC, First National Bank, Acc. No: 63035188853. No entries will be accepted without payments and/or payments into the old bank account.
- 4. <u>Show rules</u>: These will be available at the show. Please note in particular:

Show rule 28 - <u>COMMUNICABLE DISEASES</u>: NO EXHIBITOR SHALL EXHIBIT A CAT OR KITTEN WHICH TO HIS OR HER KNOWLEDGE HAS, AT THE DATE OF THE SHOW, BEEN EXPOSED TO ANY SPECIFIC COMMUNICABLE DISEASE WITHIN THE PERIOD OF 30 DAYS PRIOR TO THE DATE OF THE SHOW, AND NO CAT OR KITTEN MAY BE EXHIBITED IF THE EXHIBITOR HAS HAD ANY SUCH ILLNESS IN HIS OR HER HOME OR CATTERY DURING THAT PERIOD. IN THE CASE OF A COMMUNICABLE DISEASE HAVING OCCURRED IN A HOME OR CATTERY A CLEARANCE CERTIFICATE WILL BE REQUIRED FROM A FULLY QUALIFIED VETERINARY SURGEON. ANY EXHIBITOR WHO, IN THE OPINION OF THE COMMITTEE, SHALL HAVE MADE A FALSE DECLARATION IN RESPECT OF THE ABOVE WILL BE LIABLE TO SERVE PENALTIES UNDER THE POWERS OF THE COMMITTEE. OWNERS OF REJECTED EXHIBITS SHALL NOT PERSONALLY ATTEND ANY SHOW WITHIN THE PRESCRIBED PERIOD OF 30 DAYS UNLESS IN THE POSSESSION OF A VETERINARY CLEARANCE CERTIFICATE WHICH MUST BE EXHIBITED TO THE SHOW MANAGER ON DEMAND.

- 5. Please take note of Show Rule 19: The Committee may reserve the right to refuse any entry or entries without giving any reason.
- 6. **Stewarding:** You may steward your own cat, but if you are not at the cage of your cat when it is called for judging, the steward has the duty to take your cat out to the judge. Once the steward has your cat, they will be responsible for stewarding the cat till it has been judged and needed to be returned to the cage. You may not take over the handling of your cat during judging. This is for ALL EXHIBITORS no matter if you are a steward, judge or part of the show management team. You also may not speak to the judge while your cat is being judged.
- 7. If your cat changes status after been judged once, it will automatically be moved to the Grand or Supreme Class at no extra cost to the exhibitor, **but** the onus is on the Exhibitor when completing the entry form to make sure that all awards previously awarded, are correctly listed. i.e. the Certificate awarded and by which Judge. Any errors on the part of the exhibitor *cannot* be changed on the day of the show.
- 8. Entry fees are non-refundable.
- 9. Show details will be emailed within seven days before the show is held.
- 10. Details about the new Imperial Supreme classes for adults and neuters:

As per paragraph 16 of the SACC Show Rules, here are all the details regarding these awards:

IMPERIAL SUPREME CHALLENGE (ISCC) and IMPERIAL SUPREME PREMIER CERTIFICATES (ISPC).

- (a) Cats that are already Supreme Champions/Premiers at the beginning of a championship show, may be entered in the Imperial Supreme Challenge or Premier Class.
- (b) The cat will be entered in 2 classes per show- the normal Supreme Class as per Rule 1 and the Imperial Supreme Class.
- (c) Only one ring of Imperial Supreme Classes will be judged per show.
- (d) An All-Breeds Judge shall judge all the cats entered in either the entire or neuter classes.
- (e) A cat entered in the Imperial Supreme Class, shall not compete against other cats in breed, colour or pattern for a placing but will be judged against its breed standard. The judge will only award one Imperial Supreme Award to the cat that has the closest resemblance to its breed standard.
- (f) A judge has the right to award one cat in the entire section and one cat in the neuter section. The judge also has the right to award no certificates in either class.
- (g) A cat being awarded 6 Imperial Supremes six different judges will become an Imperial Supreme Champion or Premier.
- (h) Once a cat obtains the Imperial Supreme title, it may never take part in the class again.
- (i) If an entire cat is neutered it will keep the all points already earned in this class.
- 11. Maine Coon cats will now also be divided into colour classes in the Open and Grand classes. Please make sure that you enter the correct colour of your cat on the entry form. These classes are:
  - (a) Open Classes
    - Self
    - > Self & White
    - Patterned
    - Patterned & White
    - Shaded
    - Shaded & White
  - (b) Grand Class
    - > Self and Self & White
    - Patterned and Patterned & White
    - Shaded and Shaded & White
